Explanations

Within the scope of efforts to optimize our Company's ready-mixed concrete production portfolio and ensure the efficient use of resources, it has been resolved by our Board of Directors' decision dated 22.05.2026 and numbered 209 to terminate the ready-mixed concrete production activities at the Bařpınar Ready-Mixed Concrete Plant and to terminate, by mutual agreement, the lease agreement entered into with Limak imento Sanayi ve Ticaret A.ř. on 18.08.2025.

All other production and sales activities, in particular cement production, which constitutes our Company's principal field of activity, continue in their ordinary course.

The employment contracts of our personnel working at the Plant, together with their severance entitlements, will be transferred to Limak imento Sanayi ve Ticaret A.ř.
